- Support KK holding to pursue business opportunities for sale of KK Holding products & services by making suitable introductions to potential customers, at EVA's sole discretion
- Promote KK Holding products & services via press release(s) on EVA's website, appropriate mentions in marketing collateral, email communications, etc. at EVA's sole discretion

#### b.) Services rendered by KK Holding include:

- Promote the business module of the EVA through all appropriate means including but not limited to branding, marketing, advertising, media promotion.
- Formulate the necessary planning, marketing strategies, and make the best endeavour to make the said collaboration successful.

## Furthermore,

- Jointly share all the trade secrets and understand the technology and its marketing strategies.
- Each party assist each other party, in order to promote and understanding the specification in all manner, in lieu of the products and its related services
- Apart both parties in acquaintance with other formulate strategies, in lieu of or to promote the product within the geographical boundaries of India and Sri Lanka.
- In case of dispute between the parties such shall be resolves through Mediation, in case mediation fails then both parties can opt the method of Arbitration and Conciliation as per the UNICITRAL model, The medium of Arbitration shall be in English and the arbitration shall be governed as per the Indian Law. The venue of Arbitrator shall be at Mumbai.
